- The practices used in other jurisdictions to address asset renewal
- The relationship between a capital plan and asset renewal plan
- Next steps with respect to Council and Park Board implementation of the recommendations
- The status of the implementation of the Auditor General's 2024 recommendations.

The Board Committee heard from one speaker, who recommended the Park Board take the lead in setting the framework and priorities for the asset management plan. The speaker responded to questions from Commissioners.

3. Stanley Park Mobility Study

The Director, Park Planning and Development, introduced the item. The Associate Director, and Planner II, Planning and Policy, jointly reviewed a presentation regarding options to manage increased visitation to Stanley Park without expanding road space, by identifying opportunities and challenges of reducing private vehicle traffic and ways to improve access and visitor experience.

Following the presentation, staff, along with Paul Storer, Director of Transportation, CoV, responded to questions and comments related to:

- Concern regarding costs and revenue losses associated with developing a new transportation system in Stanley Park, at a time when the Park Board's assets are in need of renewal
- Whether there is confirmation from TransLink that funding is available for a bus route along Stanley Park Drive
- The feasibility of implementing a permanent bike lane along with a new bus service through narrow portions of Stanley Park Drive
- Whether staff could develop a cost estimate for the installation of a partial permanent bike lane in Stanley Park in time for inclusion in the 2026 capital budget:
 - Recommendation that the cost to develop a detailed plan for a permanent bike lane be included in the 2026 capital budget.

The Board Committee heard from nine speakers, of whom five spoke in opposition to the staff recommendation; two expressed opposition to the construction of parkades in Stanley Park; and two spoke in support of a Stanley Park Drive bus service. The speakers responded to questions from Commissioners.

Motion to Extend

The Board Committee heard from 11 speakers, of whom seven spoke in opposition to the staff recommendation; one spoke in support of the original intent of the Stanley Park Mobility Study; one noted the need to consider accessibility in its decision; one spoke in support of Commissioner Digby's amendment; and one recommended the increased use of neighbourhood zero emission vehicle (NZEVs) in Stanley Park. The speakers responded to questions from Commissioners.

Point of Order

Commissioner Digby raised a point of order, stating that he does not consent with the attendance of Commissioner Howard at the September 16, 2025 Board meeting if she is found to be disqualified from attending, in accordance with the Member's Motion titled "Potential Disqualification of Commissioner Howard".

Commissioner Haer raised a point of order, stating that Commissioner Digby's comments were bullying and harassment towards Commissioner Howard, as no decisions have been made yet on the Member's Motion titled "Potential Disqualification of Commissioner Howard". The Chair ruled that Commissioner Digby's comments were not considered bullying or harassment as they were conditional upon a ruling.

Commissioner Viridi raised a point of order, stating that Commissioner Digby's comments were not above the Vancouver Charter, and that they should be considered bullying and harassment. The Chair ruled that Commissioner Digby's comments were not related to the Vancouver Charter, nor were they considered bullying or harassment as they were conditional upon a ruling.

ACKNOWLEDGEMENT

The Chair acknowledged that the meeting is taking place on the traditional, ancestral and unceded territory of the Musqueam, Squamish and Tsleil-Waututh First Nations. The meeting is being held on the land respectfully and with the knowledge that there must be continued acknowledgement of the history of injustice toward Indigenous peoples. The Vancouver Board of Parks and Recreation is committed to supporting truth and reconciliation, and to use this opportunity to amplify local First Nations voices and culture through our work in community.

1. Park Board's 2025 Indigenous Peoples' Month and Day Activities

Rena Soutar, Manager, Arts, Reconciliation and Culture, introduced the item. Marie Lopes, Community Recreation Coordinator, reviewed a presentation showcasing Park Board initiatives to mark National Indigenous History Month in June 2025.

2. General Manager's Report

The General Manager presented the General Manager's Report, highlighting:

- The successful 2025 Summer Day Camp season
- 2025 Inner-City Youth Golf Program was conducted from August 25 to 29, 2025 at McCleery Golf Course
- Tatlow Park playground renewal was completed and reopened to the community in August 2025
- Construction of Collingwood Park improvements were completed in July 2025
- Improvement work at the Prince Edward playground and spray park was completed in May 2025
- The new off leash dog area (OLA) at Heather Park opened in spring 2025
- The new OLA at Grandville Park opened in summer 2025
- The new OLA at Emery Barnes Park was completed in early July 2025
- CRAB Park improvements, with financial contributions from Vancouver Fraser Port Authority (VFPA) and DP World, were completed in early August 2025
- Construction of a new temporary fence along the northern edge of the playground used by Crosstown Elementary at Andy Livingstone Park, as a pilot project
- Queen Elizabeth Park upgrades
- United Way Chili Cook-off Best Booth award went to the Park Board's Structures and Fabrication and Coating and Graphic teams from Evans Yard
- Council agenda items related to, or impacting, parks and recreation:

- Council to receive a report on September 16, 2025, titled “[Public Realm Advertising Framework](#)”, which if approved would guide the City’s approach to third-party advertising in the public realm.
- Council to receive a report on September 17, 2025, titled “[Contract Award for Operator \(Lease\) for VanDusen Botanical Garden Restaurant](#)”, which would authorize staff to negotiate an agreement for Operator of VanDusen Botanical Garden Restaurant.
- Council to consider a motion on September 17, 2025, titled “[Prioritizing the Completion and Delivery of Community Facilities and Infrastructure in the 2027-2030 Capital Plan](#)”, which would direct staff to prioritize the renewal and delivery of core community facilities and essential infrastructure, with a focus on aging and end-of-life assets

During discussion, concern was expressed that the installation of the fence to delineate Crosstown Elementary School from Andy Livingstone Park would create a precedent.

MEMBERS’ MOTIONS

1. Potential Disqualification of Commissioner Howard

Commissioner Bastyovanszky introduced the motion and responded to questions from the Board.

Main Motion

WHEREAS:

1. Section 144 of the Vancouver Charter provides that a Commissioner who is absent from meetings of the Board for a period of 60 consecutive days or 4 regularly scheduled meetings, whichever is the longer time period, without leave of the Board ceases to hold office;

2. Commissioner Howard has missed three consecutive Board meetings on three separate occasions, placing her one meeting short of the threshold for disqualification under Section 144 of the Vancouver Charter;
3. Commissioner Howard has been absent without leave from 60% of Board meetings in 2025 missing 6 of 10 meetings, her recorded absences for 2025 are:
 - January 20, 2025 – Absent
 - February 3, 2025 – Absent
 - February 24, 2025 – Absent
 - May 12, 2025 – Absent
 - June 2, 2025 – Absent
 - June 16, 2025 - Absent
4. Commissioner Howard was absent from the following consecutive regular meetings of the Vancouver Board of Parks and Recreation without leave in 2025;
 - January 20, 2025 – Absent
 - June 2, 2025
 - June 16, 2025
5. Commissioner Howard was recorded as absent for a portion of the meeting on April 14, 2025, which may constitute a fourth consecutive absence and requires a legal opinion; and
6. Commissioner Marie-Claire Howard has demonstrated a consistent pattern of absenteeism, lack of transparency, and disregard for obligations under the Vancouver Charter, raising serious questions about her capacity to serve in public office.

THEREFORE BE IT RESOLVED THAT the Vancouver Board of Parks and Recreation refers the matter to legal counsel for review and confirmation of the applicability of Section 144 of the Vancouver Charter to Commissioner Howard's attendance record, and requests that legal counsel provide a recommendation to the Board on appropriate next steps.

- A. The Vancouver Park Board reiterates that it unequivocally supports the lives and rights of Two-Spirit, transgender, and gender-diverse people, and it will continue to celebrate and honour their communities, and to support the specific needs and opportunities of these communities;
- B. The Vancouver Park Board recognizes that transphobia sets a precedent to the reduction in human rights that affects all of us;
- C. The Vancouver Park Board directs staff to report back on actions the Park Board can take, including financial actions and public statements, to address the harms caused to Two-Spirit, transgender, and gender-diverse people by hosting the Harry Potter™ event;
- D. The Vancouver Park Board directs staff to separately report back on contract options to ensure that the Harry Potter™ event runs for one season only;
- E. The Vancouver Park Board acknowledges that it failed in its policy commitment to consult with the 2SLGBTQ+ Committee in advance of hosting the Harry Potter™ event, a failure which would likely have identified the reputational concerns of hosting the event; and
- F. The Vancouver Park Board directs staff in the business services group to, in the future, conduct deeper investigations into the reputational aspects of potential hosted events, and to present a fulsome account of such risks to Commissioners at the time approval is requested. Requests for confidential approval by potential suppliers shall be viewed with extreme skepticism going forward.

2. Enjoy the Sunset in Vancouver

Commissioner Digby submitted a Notice of Motion on the above-noted matter. The motion below may be placed on the Board meeting agenda of the October 6, 2025, as a Member's Motion.

THEREFORE BE IT RESOLVED THAT the Vancouver Park Board hereby directs staff to prepare a bylaw amendment for approval by Commissioners extending the public hours on ocean beaches facing English Bay to 11:00 pm from Victoria Day long weekend to BC Day, each year, inclusive

3. Think Free Play: Expanding Sports Access in Vancouver Through Self-Service Equipment Stations

Commissioner Virdi submitted a Notice of Motion on the above-noted matter. The motion below may be placed on the Board meeting agenda of the October 6, 2025, as a Member's Motion.

THEREFORE BE IT RESOLVED THAT the Vancouver Board of Parks and Recreation direct staff to work with Canadian Tire Jumpstart Charities and Equip Sport to pilot a free sports equipment lending program in Vancouver parks and facilities, modeled after the Surrey initiative, with a report back to the Board following the first year of implementation; and

FURTHER THAT the Vancouver Board of Parks and Recreation affirm and direct that accessibility, equity, and inclusion be prioritized in this initiative, ensuring that residents of all ages, abilities, and backgrounds can participate in sport without financial or logistical barriers.
